

Consent to the processing of personal data

The person who has confirmed their specific, informed, unambiguous, specific and conscious consent on the Website <https://evisa-centrafrique.com> (hereinafter referred to as the «personal data subject» and the «Website» respectively) hereby gives their consent to Digitalgate SARL (hereinafter referred to as the Operator), registered in the Central African Republic, to process their personal data and the personal data of persons on whose behalf they act (including minors), namely data on the first and last name, type, number, date of issue and expiration date of the identity document of a foreign citizen, date of birth, gender, citizenship (nationality), city and country of birth, current citizenship (nationality), residential address, marital status, occupation, name of employer, employer address, full name of father and mother, contact telephone number and e-mail, photographic image and yellow fever vaccination status, data on purchases made, IP address, cookies, geo-position.

The Operator processes the personal data of the personal data subject by any means, including but not limited to collecting, recording, organizing, adapting, extracting, copying, consulting, systematizing, accumulating, storing, clarifying (updating, changing), organizing, using, transferring (distributing, providing, accessing), depersonalizing, blocking, encrypting, deleting, erasing, destroying personal data.

The Operator processes the personal data of the personal data subject for the purposes of:

- concluding and performance contracts for the provision of paid services that personal data subject conclude with Operator by joining the Offer posted on our Website;
- submitting applications and documents for an electronic visa on your behalf - where applicable;

If the subject of personal data wishes to revoke this consent to the processing of personal data, he must send the Operator a written revocation of consent to the email address: (subject of the letter: "personal data").

In the event that the subject of personal data revokes consent to the processing of his personal data, the Operator undertakes to stop their processing or ensure the termination of such processing (if the processing of personal data is carried out by another person acting on behalf of the Operator) and, if the storage of personal data is no longer required for the purposes of processing personal data, to destroy the personal data or ensure their destruction (if the processing of personal data is carried out by another person acting on behalf of the Operator) within a period not exceeding thirty days from the date of receipt of the revocation.

The destruction of personal data by the Operator will entail the immediate termination of the provision of services by the Operator purchased on the Website, since access to such services is provided on the basis of personal data available to the Operator. Location of data storage servers: Germany.

Transfer method - using the Internet.

Transfer period - from the moment the personal data subject concludes the Offer posted on the Website until the completion of the Offer.

Storage and use period of personal data: 10 years. The operator and its subcontractors may terminate the processing of personal data earlier without notifying the subject of personal data.
